

Notice to Mariners

Vessels and General Safety Advice

Scottish Hydro Electric Power Distribution (SHEPD)

Date of Issue: 11th August 2026

Please be advised that Briggs Marine Contractors (on behalf of SHEPD) will be undertaking earthing and split pipe remedial works within the nearshore environment at Head of Work, Orkney.

Please refer to Figure 1, that shows the location of the full cable route, the working area is defined by the red box. Please also refer to Table 1 overleaf, which lists the coordinates.

Works at Orkney are expected to commence 17th August and are expected to take 1 day to complete (weather permitting).

Work Description

Site personnel will be fitting 2m of split pipe cable protection and trenching an existing sea earth wire at the shore end. A clump weight will then be deployed 30m out from Mean Low Water Springs. Shore Worker 1 support boat will be utilised to offer support to personnel.

Operations will be conducted during daylight hours only and are weather/tide dependent.

Legal Notice

Failure to remove equipment or entry into the identified location in a manner that would constitute a hazard may constitute a breach of duty of care at common law, and a failure to protect submarine cables for successful seabed user co-existence under Scotland's National Marine Plan.

SHEPD shall found on this notice in the event of any damage, loss or disruption arising from failure to heed the information herein.
